



## WATERPARK RULES AND POLICIES

### ASSUMPTION OF RISK

1. I acknowledge that there are inherent risks and dangers associated with engaging in activities at the Canad Inns waterpark, pool, slide and related areas (referred to collectively as the **"Canad Inns Waterpark"**). I acknowledge that the nature of these risks and dangers include, but are not limited to, the possibility of personal injury, illness, disease, physical or psychological damage, damage to personal property, death and loss resulting from those things. I acknowledge that these risks and dangers may be caused by my own actions or inactions, the actions or inactions of other individuals or hotel guests, or the negligence of the Released Parties named below, and I fully accept and assume all such risks, dangers and responsibility for any losses, costs or damages that I may incur as a result of my use of the Canad Inns Waterpark.
2. **I acknowledge that Canad Inns' rules and policies are posted in the Canad Inns Waterpark and that it is my sole responsibility to read them and to abide by them. Waterpark usage is restricted to registered guests only and all waterpark users must wear a Canad Inns wrist band. I further acknowledge that no lifeguard is on duty, that children under the age of 16 must be supervised, and that no horseplay is permitted at the Canad Inns Waterpark at any time.**

### RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

3. I hereby release, waive, and discharge Canad Inns, its affiliates, directors, officers, managers, shareholders, partners, agents, employees, volunteers, independent contractors, subcontractors, successors, assigns, and each of their heirs and personal representatives (referred to collectively as the **"Released Parties"**) from any and all liability for any loss, damage, injury or expense that I may suffer, of whatever nature and however caused, including any liability that may arise, or any damage to personal property, illness, personal injury or death that may be caused, or contributed to, by the use of the Canad Inns Waterpark or the misconduct, negligence or gross negligence by the Released Parties in the course of my use of the Canad Inns Waterpark.
4. I agree to indemnify, save and hold harmless the Released Parties from any and all actions, proceedings, claims, damages, costs, and liabilities of whatever nature or kind arising out of or in any way connected to my use of the Canad Inns Waterpark.
